M3 improvements September 2023

The M3 (Shades of Death) cave electricity generator exhaust is now vented to outside of the

machinery shed. The generator was moved closer to the shed's east wall. A 5cm diameter metal pipe was fixed through the corrugated metal shed wall and an extension attached to the generator exhaust to fit into the 5cm exit pipe.


Replacement power leads were installed on a new cable runway from the generator to the power distribution panel.

Inside M3 the cave lighting was improved near the end of the "Hall of the Mountain King" chamber. The massive flowstone area near the end of the "Hall" is now highlighted nicely (see photo below).

Rimstone Directors' Meeting Minutes Summary 9 October 2023

On 9th October, the first Rimstone directors meeting since the AGM, was conducted via Zoom with attendees: Nigel Cooke, Nadine Muresan, Peter Stewart, and Tom Elms, while Paul Brooker sent his apologies.

Key appointments included: Nadine Muresan as Chairperson, with Nigel Cooke taking on the roles of Treasurer and Membership Officer. Nigel and Nadine jointly manage Homeleigh Bookings, with a future goal of automating the process. Paul Brooker has been assigned the responsibilities of Property Manager for Homeleigh, and Peter Stewart remains as the Secretary.

Nick White now manages Scrubby Creek property, and Daryl Carr is responsible for M3 Shades of Death cave. Sandra Brooker oversees Homeleigh supplies, while Rob Brain holds the positions of Newsletter Editor and Website Manager. Tom Elms is flexible in his role, offering assistance as required and taking on specific projects as needed.

At the meeting there was a discussion about M3 cave's specific projects and the need for more communication with members. This included the clarification that "access to the wild sections of M3 is for specific projects only" and currently the only project is the survey (Nigel Cooke).

Nadine addressed concerns from some members regarding a lack of communication from the directors to the general membership. It was decided to work towards releasing a monthly newsletter that includes a summary of the previous meeting's minutes and other relevant information.

Homeleigh

Discussions at the meeting revolved around various Rimstone projects, such as Homeleigh's internal bathroom project, working bees, and plans for the organisation's 50th Anniversary in 2024

The need for an archive of essential documents was addressed, and the potential refurbishment of the large bungalow was suggested as a priority target. The meeting also touched upon concerns related to the septic tank, which will be pumped out to prepare for the installation of the new bathroom.

Nadine will run a working bee from 14th to 17th December to finish painting the veranda balustrade and the workshop/equipment store. The external timber of the north window of the lounge room has weathered and requires attention.

Grumblings from the treasurer

Now that the AGM has concluded, it is imperative to remind all members who have not yet paid their annual subscription that it is overdue. It is crucial for all members to fulfil their obligation to pay their annual subscriptions, as this not only upholds their status as members but also grants them the rights associated with membership.

Those members who remain unfinancial are, in essence, non-member shareholders, as per the model rules. Non-members cannot actively participate in meetings, address the board as a member, make bookings at Homeleigh, or claim members' rates for their stay at Homeleigh, among other privileges. For those who have promptly paid their annual subscriptions, thank you for your diligence and commitment.

Forfeiting your Rimstone shares - Now, if I may put on my grumpy hat, it is worth noting that the model rules provide for the forfeiture of shares belonging to members who are not financial. In simpler terms, they could risk losing their membership. Regrettably, we currently have several members who are several years behind in their payments, despite repeated reminders and requests for settlement. In my role as Treasurer and in the best interest of safeguarding the cooperative's financial health, I will be referring these cases to a director's meeting with the intention of recommending the forfeiture of their shares. This is a step I do not take lightly but is necessary to prevent the accumulation of bad debt

Failing to pay for accomm – Another issue of concern for the Treasurer is the occurrence of members who utilise Homeleigh facilities and neglect to make their payments. This issue extends not only to the member but also to the Member-in-Charge (MIC).

One of the key responsibilities of the MIC is to ensure that all members and guests settle their accommodation charges before departing Homeleigh – a policy that has been in place for decades and remains unchanged.

Some members have admirably adopted the practice of paying upfront, even before arriving at Homeleigh, for which I am genuinely appreciative. This practice not only simplifies the MIC's responsibilities but also reduces my workload as Treasurer.

In today's digital age, it has become common for payments to be made online, and cash transactions have become a rarity. Online payments can be conveniently completed at any time, including before one's arrival at Homeleigh.

For those who still wait to be prompted for payment, it's important to note that online payment is now available at Homeleigh, thanks to our WiFi access. Therefore, regardless of their mobile carrier, there is no reason for members to delay payment beyond the conclusion of their stay at Homeleigh.
